Chamber's Political Action Committee Announces Their **Endorsements for Bloomington City Council & Normal Town** Council

Bloomington, IL - Today the McLean County Chamber of Commerce (MCCC) Political Action Committee (PAC), a separate subsidiary entity from the Chamber with its own Board of Directors, announced their endorsements for Bloomington City Council and Normal Town Council. The MCCC in an effort to educate its members previously released its 2023 Council Questionnaire responses from all thirteen candidates running for office and held a Meet the Candidates event.

"These candidates either demonstrated their commitment to pro-business, pro-growth policies or expressed a willingness to work with the Chamber to better understand key issues impacting the business community," said Chair Meghan O'Neal-Rogozinski. "We encourage voters to support these candidates at the ballot box on April 4th. Doing so will ensure we have elected officials who understand the need for a business-friendly environment in Bloomington-Normal."

City of Bloomington

Ward 1: Jenna Kearns

Jenna Kearns is unopposed and demonstrated a commitment to engaging the business community by participating in the Chamber's questionnaire and Meet the Candidates event. She has expressed a willingness to work with the Chamber and business community to learn more about the issues facing business in Bloomington.

Ward 2: Donna Boelen

Donna Boelen is unopposed and has engaged with the business community often during her term in office. She has proven to be a voice for business and the Chamber looks forward to continuing to see that be the case.

Ward 4: No Endorsement

John Danenberger and Steven Nalefski both participated fully in the endorsement process. Following the conclusion of that process it was found that both bring their own unique perspectives in relation to probusiness, pro-growth policies. Therefore, we encourage voters to utilize the Chamber's questionnaire to make an informed decision on which candidate to support.

Ward 6: Jordan Baker
