1. What are your top three priorities if you are elected to the McLean County Board?

Veteran Services, mental health services, and transportation.

2. What is the greatest challenge(s) the County faces? How do you propose to address said challenge(s)?

Based on recent COVID-19 restrictions, the economy in McLean County has been impacted due to loss of revenue, business closures, and unemployment. Now more than ever it is critical that the board work together to ensure we are operating effectively and efficiently within the approved budget. As a County board member, I would create accountability with county projects to guarantee they are meeting deadlines and are within budget.

3. If elected to the County Board, how would you work with the municipalities to enhance and ensure regional collaboration?

Ensuring and enhancing regional collaboration comes down to relationship building. This is one of my personal strengths. I enjoy meeting new people, learning about their background and their skills. It has always been important to me to hear and learn from other people's perspectives. 5. Do you consider McLean County to be encouraging of business growth, expansion, and attraction? Please explain.

I do not believe we are lacking government services; I believe we are lacking an effective communication strategy to promote the services that are currently available. My plan as a County board member would be to improve public knowledge using the County board website and social media. Currently, I am not able to determine if there are any non-essential services due to the need to improve public knowledge. Once awareness is created, then additional research can be conducted to determine the effectiveness of programs.

## 9. Do local government(s) have a role to play in COVID-19 recovery efforts?

Local governments absolutely plays a role in COVID-19 recovery efforts and it all starts with communication. The public needs to be provided with unbiased information regarding COVID-19 trends including the number of recovered cases and demographics. Local governments should also collaborate with the local medical community to implement preventative measures that can be taken to help slow the spread. Decisions to re-open or continue restrictions must be based on relative medical information and public safety rather than political agendas.
